## STATEMENT OF AGREEMENT

In exchange for membership to the Sunnyside Gardens Community Association, I agree to pay the membership fees, assessments and initiation fee as required. I further agree, in exchange for said membership, to abide by the constitution, by-laws, rules and regulations of the Association.

Membership Classes II and III are required to perform 12 volunteer hours per year. Membership Classes I and V are required to do 6 hours. Half of the required hours must be completed and/or paid for by July 31 (Class IV Seniors are exempt from this obligation). \$20.00/hr for each remaining volunteer hour will be billed and must be paid before membership renewal can take place.

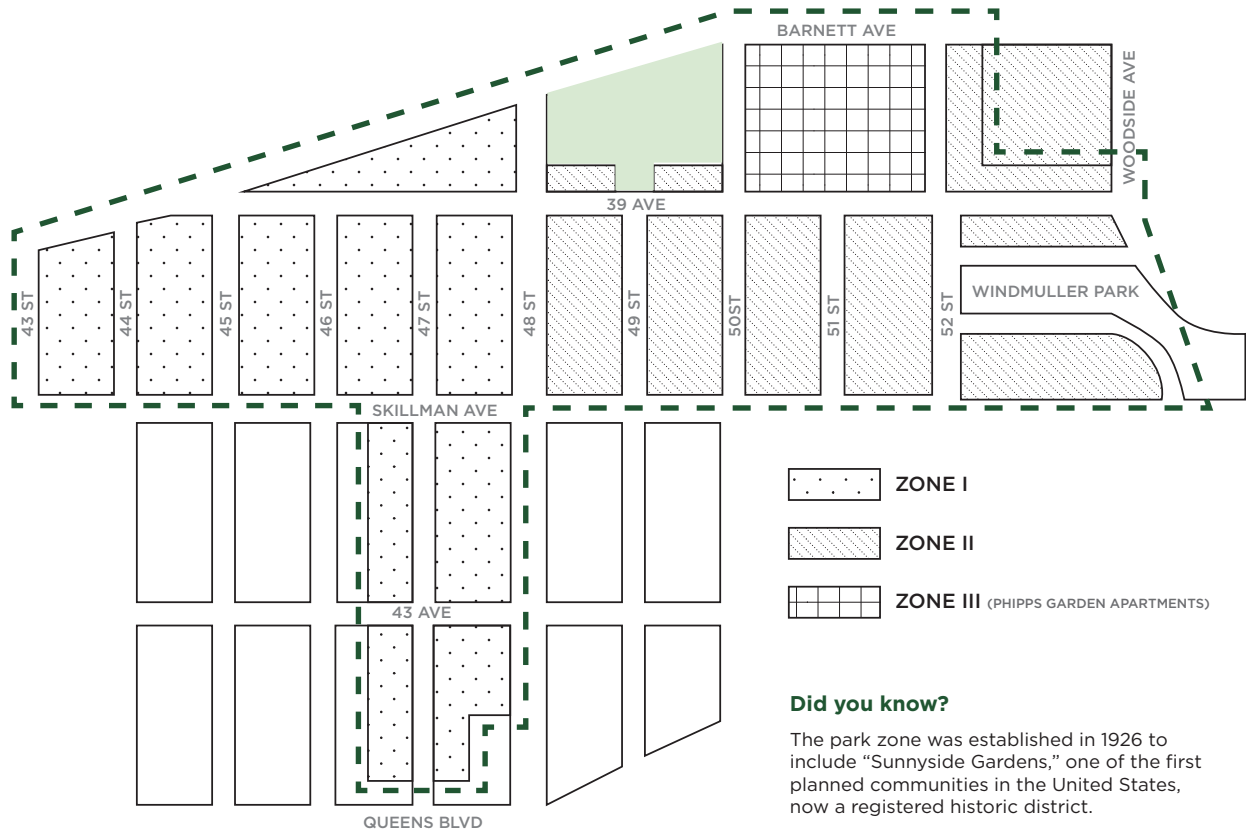

## APPLICATION PROCESS

- Prospective new members fill out an up-to-date Membership Application, providing names of all immediate family members and their dates of birth. Applicants must live within the 3 zones and show proof of address in the form of a utility bill.
- The park office reviews the applicant's credentials and sends the completed application and proof of address to the Membership Committee for review and approval.
- The process takes 1-2 weeks; the applicant will be contacted by the office when the Committee finishes reviewing the application.
